10	interested in what I had to say because his innocence was not
11	really an issue before the board.
12	I know that the board should consider this because
13	Robert Kennedy's even though we lost him that night, was a
14	man of justice, and he would be interested in Sirhan being
15	treated in a just way, and he he was not, and I hope this
16	board will consider that as important in in releasing him.
17	Bobby Jr. has been to visit Sirhan while in
18	prison and has assured Sirhan that he knew that he did not kill
19	his father and should also be released.
20	My friend Bobby Kennedy I shouldn't say that. My
21	friend Robert Kennedy never call him Bobby my friend,
22	Bob Kennedy, was a man of justice. He served as Attorney
23	General in the United States and and did an excellent job
24	that way, and he would if he were here speaking, I'm sure
25	would want Sirhan to be treated justly as well.
